## Socialism or Neighborliness?

By Graham H. Walker and Phillip W. Magness

When vice presidential candidate and Minnesota Governor Tim Walz said that "one person's socialism is another person's neighborliness," many allegedly right-thinking people nodded their heads sagely. But they were wrong. Neighborliness is when you take up a collection for the family on the block that got hit with a tragedy. Socialism is when government bureaucrats dictate how much you can earn, how big a cut others should get from your wages, and how much of a cut they'll take for themselves—usually a big one. If socialism is neighborly in any sense at all, it's a counterfeit.

By contrast, here at the Independent Institute, we aim to foster "peaceful, prosperous, and free societies grounded in a commitment to human worth and dignity." This has everything to do with real neighborliness and friendship, and nothing to do with government direction.





After all, what do genuinely free people do? Except in rare cases, they don't isolate themselves; they seek out others. They form friendships with coworkers and neighbors. They make music together. They gather in churches and synagogues and mosques to connect themselves with God. They make permanent commitments to one another in marriage. And in a free society, no one forces them to do these things.

The problem with governmental power of all grades—whether to the extreme of socialism or not—is that it is coercive. It intrudes itself into the spheres of natural collaboration. Where people would—indeed must—otherwise come together to voluntarily solve problems, instead they become passive subjects of state programs. They become explicitly or implicitly wards of bureaucrats.

Passive subjects are deprived of their human dignity. The more passivity, the less dignity. The more liberty, the more dignity—and the

While we are delighted that Americans roundly rejected the false narrative peddled by the Democrats—that individuals are defined wholly by our race, gender, socioeconomic status; that we are divided into "oppressors" and "oppressed"—the winning side's agenda presents several challenges to liberty and prosperity.

On the bright side is the DOGE initiative, and we sincerely hope it produces more lasting change than have its predecessors—including the 1980s' Grace Commission and Greenspan Commission, the 1993 National Partnership for Reinventing Gov-

We keep this vision for decentralized educational opportunities alive and thriving through topical commentaries, op-eds, and postings daily, as well as new book projects building on and amplifying the message.

We push for a more humble foreign policy and giving up the fruitless crusade of spreading "freedom" abroad while losing it at home, in cogent and practical books like *In Search of Monsters to Destroy* and the ongoing work of our Center for Peace and Liberty.

As the recent election outcomes also show, Americans are not fools and are well aware that profligate politicians have immiserated them by inflation. 

# Fall 2024: Anarchy, State, and Utopia—Robert Nozick's Classic at 50

Bold and often controversial. The Independent Review is a one-of-a-kind academic journal of political economy featuring discussions on politics, economics, and culture for critical minds of every stripe. The cover feature of the Fall 2024 issue fits well in these categories: Robert Nozick's landmark book Anarchy, State, and Utopia (ASU) sent shockwaves through the world of political philosophy when it was published fifty years ago, and it continues to inspire great minds today.

Anarchy, State, and Utopia won the 1975 U.S. National Book Award in the category of Philosophy and Religion. It has been translated into 11 languages, and The Guardian (U.K.) proclaimed Nozick "one of the 20th century's greatest political theorists." Nozick's opening assertion-"Individuals have rights, and there are things no person or group may do to them (without violating their rights)"-may strike the man in the street as selfevident. The fact that it was and is shocking to political philosophers and social critics reveals their disconnect from common sense.

Nozick's message and character uniquely animates each essay in this symposium. The issue also features a historically grounded condemnation of price controls (Erik Watson, George Mason University), a breakdown of capitalism versus socialism (Peter J. Boettke, George Mason University), 30 book reviews, and, a century later, a profound reflection on the Immigration Act of 1924 (Richard K. Vedder, Ohio University; Matthew Denhart, Calvin Coolidge Presidential Foundation).

Coincident with the symposium's publication, the Independent Institute held an evening event and discussion at its headquarters in Oakland. Featured contributors to the syposium revisited Nozick's rational, complex, and balanced case for individual liberty and limited government. Nozick's daughter opened the event with reminiscences of her father.

Gregory Robson, who organized the symposium, opened with an overview of ASU, noting that it masterfully refuted social-justice statism—but it also rankled many conservatives and libertarians. Core themes include the existence of strong

private property rights, the limits these impose on political actors including states, and the value of a society of diverse people who are free to lead their own lives and experiment with different forms of social arrangements and values, leaving others free to do the same. Yet, he noted, a key theme is often missed: it is not just a remarkable work in political philosophy. It is also a notable contribution to our understanding of the logic of market exchange—and thus, *business*—and its centrality to philosophical questions around distributive justice. *ASU* concerns both the business or subject matter of liberty and the liberty of business.

Christopher Freiman, co-author of the article "Putting Wilt Chamberlain Back in the Game: Why Liberalism Is Not Compatible with Distributive Egalitarianism," drew on Robert Nozick's example of basketball player Wilt Chamberlain to critically resist the view that the state should use its power to promote and maintain egalitarian distributions of goods. Regardless of Chamberlain's success owing partly to natural luck in his physical stature and athleticism, his financial success comes from willing fans paying to see him play, and thus no injustice has occurred.

Important to the evening's dynamism, the participants not only expressed their admiration of Nozick, deepening our understanding of his seminal work, but also honored him with important disagreements and reinterpretations, prompting lively discussion.

# Wirth Institute Conference on Austrian Economics

The 9th Biennial Wirth Institute Workshop on Austrian Economics, held in Kraków, Poland, celebrated the 50th anniversary of the Nobel Prize awarded to F. A. Hayek. Senior Fellow and David J. Theroux Chair in Political Economy Phillip Magness presented a thought-provoking reflection on the resurgence of socialist and Marxist ideas to the assembled academics. His talk drew from Hayek's *The Intellectuals and Socialism*, a seminal work on the draw of utopian socialist ideas for intellectuals and a challenge for classical liberals to meet them in kind.




